### Background

### ROLES OF INTERNS

#### 1. Project Monitoring and Quality Control

- Oversee ongoing WASH construction projects to ensure they meet design specifications and quality standards.
- Conduct site visits to verify adherence to safety, environmental, and technical standards.
- Implement quality control and assurance processes at all project stages to maintain high construction and operational standards.

#### 2. Project Assessments and Design

- Participate in assessments to identify community needs and design tailored WASH solutions.
- Develop water supply, sanitation, and hygiene systems, using software like EPANET for hydraulic Modelling, AutoCAD for technical drawings, and Design Excel for calculations.
- Collaborate with senior engineers to create accurate, feasible project plans and specifications based on assessment data.

#### 3. Data Collection, Documentation, Monitoring and Reporting

- Conduct infrastructure mapping and data collection, utilizing mWater software to monitor project outputs and track infrastructure status.
- Gather and analyse data on water sources, community usage, and water quality to inform project decisions and reporting.
- Prepare and submit weekly reports detailing project progress, assessment results, and any challenges encountered.
- Document construction milestones, quality control activities, and community engagement outcomes.

- Maintain organized records, including technical drawings, reports, maps, and project documentation.

#### **4. Training for CBWSO, Community Engagement and WASH Awareness:**

- Actively engage with local communities to foster support and understanding of WASH projects.
- Lead community awareness sessions on safe water, sanitation, and hygiene practices, encouraging long-term positive behavioural change.
- Engage with local leaders and stakeholders to ensure alignment of project activities with community needs.
- Plan and deliver training sessions for CBWSO members on WASH infrastructure management and maintenance.
- Develop and distribute training materials covering topics such as water system maintenance, health practices, and community hygiene.
- Foster knowledge-sharing and capacity-building within communities to enhance project sustainability

#### **5. Technical Support and Compliance**

- Ensure all activities adhere to health, safety, and environmental guidelines throughout the project lifecycle.

#### **6. Safeguarding**

- Ensuring alignment to safeguarding of program activities
- Ensure safeguarding training and orientation for all sector partners including community level

#### **Minimum qualification of the Interns**

1. Education: Bachelor's degree in Water Engineering, Civil Engineering, Environmental Engineering, Municipal and Industrial Services Engineering or a related field.
2. Experience: At least 1 year of relevant experience in the WASH sector, with exposure to project monitoring, community engagement, and technical design.
3. A minimum of 1 years' experience in WASH hardware implementation
